It is rare that we think of conflict as something positive. Yet all growth creates conflict. So does change. If we look at conflict as an opportunity for growth, change, improved understanding, intimacy, improvement, communication or reconciliation, we may be able to approach it with the goal of learning, rather than aiming for self-protection or the infliction of pain. **Resolving conflict constructively is rarely about who is right.** It is about acknowledgement and appreciation of differences, learning, growing and cooperating are goals for conflicts.

We want them to have self worth . . .

So we destroy their self-worth.

We want them to be responsible . . .

So we take away all responsibilities.

We want them to be part of our community . . .

So we isolate them from our community.

We want them to be positive and constructive

So we degrade them and make them useless.

We want them to be trustworthy . . .

So we put them where there is no trust.

We want them to be nonviolent . . .

So we put them where there is violence all around them.

We want them to be kind and loving people . . .

So we subject them to hatred and cruelty.

We want them to quit being the tough guy . . .

So we put them where the tough guy is respected.

We want them to quit hanging around losers . . .

So we put all the losers in the state under one roof.

We want them to quit exploiting us . . .

So we put them where they exploit each other.

We want them to take control of their lives, own their problems, and quit being a parasite...

So we make them totally dependent on us.
